HISTORY

The New Jersey Library Association History & Preservation Section is an individual member section open to any person who has paid all dues assessed by the New Jersey Library Association. The objectives of the Section are to recognize and promote the work of New Jersey libraries and their professional employees who collect, organize, conserve, preserve, publish, and interpret historical materials; to encourage and promote publications dealing with the history of New Jersey; to foster the exchange of information through workshops, lectures, tours, and other programs; and to provide a liaison between the Section and other agencies and organizations engaged in the fields of history and preservation. The History & Preservation Section has five standing committees, including Nominating, Program, Awards, Constitution and Bylaws, and History & Preservation Section Archives.

The History & Preservation Section was formed by a merger of two earlier sections: the History & Bibliography Section (formerly the Bibliography Section) and the Preservation Section. The following historical summary is based on a special 2013 issue of *The Chronicle* prepared by Elsalyn Palmisano and Fred Pachman. For further detail, see that publication, which is available in the collection.

As early as April 1961, the NJLA Bibliography Section published a newsletter, *New Jersey Bibliography*. The section published a numerous bibliographies including "New Jersey and the Negro." Section leaders Bernard Bush, later the first Director of the New Jersey Historical Commission, and Donald Sinclair of Rutgers Special Collections were instrumental in transforming the Bibliography Section into the History and Bibliography Section on May 3, 1968. Under the leadership of Rebecca Huehleck from the Trenton Public Library who served as first Section President, this group evolved and prospered throughout the 1970's in the 1980's as one of New Jersey's foremost historical groups. During the term of President Elsalyn Palmisano (1981-1982), the Section fielded the following committees:

- ► Afro-American Committee
- ► Graphics Committee
- ► Library History Committee
- ► New Jersey Folk Life Committee
- ► Genealogy and Family History Committee
- ► Oral History Committee
- ► New Jersey Bibliographer Committee
- ► New Jersey Historical Research Committee

Programs included:

- ► Workshop on map librarianship and a bibliography or New Jersey maps was published in 1972.
- ▶ Program at the NJLA annual conference at the Boardwalk Regency Hotel in Atlantic City on April 30, 1980 "Family History and Genealogical Resources in New Jersey: Locating and Using Them to Build Library Support."

The first issue of the History and Bibliography's newsletter, *The Chronicle*, Fall 1977, was edited by Elsalyn Palmisano, who also provided the title for this periodical.

An organizational meeting for the NJLA Preservation Section was held on March 4, 1983, at the Dana Library, Rutgers, in Newark. Fred Pachman, Monmouth Medical Center Library, was one of the signers on the original petition to the NJLA Executive Board. On April 25, 1984, the NJLA Preservation Section was officially formed with the creation of by-laws and appointment of an Executive Board with Madelyn DeSantis and Susan Swartzburg as co-presidents. The first Preservation Section program was presented at the New Jersey Library Association Annual Conference in Atlantic City, April 24, 1983, entitled "Preservation Action for the 80's."

The Preservation Section often cosponsored educational programs with other organizations and sections. For example, in the 1990s, the Preservation Section and the Regional Library Cooperative V - Preservation Committee co-sponsored preservation film festivals and specialty workshops such as pest control and book repair. The History & Bibliography and Preservation sections c o - s p o n s o r e d a p r o g r a m at the NJLA Spring Conference at Resorts International in Atlantic City on May 11, 1988 titled "Issues in Preservation of Local History Collections." A memorable reception hosted by the Atlantic City Public Library and sponsored by both Sections followed the program.

Section members also contributed individually to many publications and projects, including the 1985 Spring issue of *New Jersey Libraries*, a theme issue on "Preservation." Editors were Susan G. Swartzburg and Neha Weinstein, both of Rutgers University Libraries. In September of 1984, State Librarian Barbara Weaver contracted with the Northeast Document Conservation Center to conduct a study of the needs for preservation of collections materials in New Jersey libraries and to develop a statewide plan for addressing those needs. Project Director Howard Lowell of the Oklahoma State Library presented the report to selected Section members who were appointed to the Conservation Study Advisory Committee. One of the results was an active grants program for preservation initiatives in New Jersey libraries, funded by the New Jersey State Library.

The first issue of the *Preservation Section Newsletter* appeared in Fall 1985 and was edited by Susan Swartzburg. Swartzburg had an international reputation as a preservation advocate. She was Preservation Librarian at Rutgers University Libraries, where she taught the graduate-level Preservation course to future librarians and archivists. She was also founder and president of the Princeton Preservation Group, initiator of the post-Masters certificate offered by Rutgers in Preservation Management, and frequent contributor to preservation newsletters such as Abbey Newsletter and Conservation Administration News. The last Preservation Section Newsletter, Spring/Summer 1996, Volume 12, Issue 3, was also edited by Susan Swartzburg. Swartzburg's memory is maintained by two annual awards for preservation: the George Cunha-Susan Swartzburg Award of the American Library Association, given since 2008; and the Susan Swartzburg Award, selected by the History & Preservation Section since 2003.

In Spring 1998, after the History & Bibliography Section merged with the Preservation Section, *The Chronicle*, edited by Betty Steckman of the New Jersey State Library, became the primary news and publicity organ for the NJLA History & Preservation Section. The first issue under the combined sections' auspices was designated Volume 1, Number 1. Steckman continued as editor until 2002. Subsequent editors have been Joanne Parra (2003-2009); Mary McMahon (2009-2010); B. Joyce Watson (2011-2013); and Sarah Hull (2013-2017).

Throughout the 1980's and 1990's, both the History & Bibliography and Preservation sections continued to thrive independently. But since the work of both entities often complimented each other, they officially merged into the History and Preservation Section in 1997. The first combined Section Presidents of the modern era were Korin Rosenkrans and George Cooke who continued a legacy of history and preservation advocacy that continued into the 21st Century.

SCOPE AND CONTENT

The materials in the collection relate to the records of the History & Preservation Section and its two predecessor sections, the History & Bibliography Section and the Preservation Section. A small amount of information relating to the umbrella organization, the New Jersey Library Association, is also included, some of which mentions Section business and programs. Types of materials include agendas, annual reports, constitutions and by-laws, correspondence, member lists, minutes, newsletters, and other miscellaneous and related material. The collection is arranged in four series.
