- d. BibFRAME program
Ashley will contact Sharon Yang of Rider University. The Emerging Technologies Section may wish to co-sponsor.
- e. Other conference program ideas include a session by Terry Reese, creator of MarcEdit, and a digitization follow-up program so-sponsored with History and Preservation.
